April is Fair Housing Month. Angle gave an introduction to Fair Housing (FH) and Affirmatively Furthering Fair Housing (AFFH-HUD).

2022 Financial Statements: Daphne went over the draft 2022 of financial statements overview. She thanked the staff and the committee for all their hard work. Income for the year was just over \$6 million, while expenses for \$4.9 million; net income was \$630,000. Cash on Hand is 103 days. COVID relief funds helped with these results. We expect increased funding in the next year as well. Currently we have almost \$22 million in total assets, and \$13 million net assets.

Angie reviewed 2022 Highlights & the year ahead

Kevin adjourned the 2023 Annual Meeting.

2021 Highlights: Connie Snow, interim CEO spoke about the housing crisis in Vermont and the country. Pointed out Downstreet provides 875 people housing in 500 households, including 440 apartments in 58 building in 8 towns; plus 82 mobile home lots in 4 parks. 25% of our residents were homeless in the past, and/or are children. She also highlighted, among other things, SAH served 577 participants. She highlighted some projects, including the Welcome Center at Twin City, 3 new ZEM homes at Whistlestop, Wells River renovation project, development work at Fox Run continues and work is starting at the Barre Recovery Residence. Over 270 donors helped make this project possible.

She also highlighted work at the Home Ownership Center, who consoled 176 people and help families purchase 100 new homes, among other accomplishments.

Dan thanked Connie for her leadership.

Year Ahead: Dan shared an update on the search for a new CEO; an announcement is expected in the next few days. He also gave glowing commentary on the incredible work that the staff has done, especially given the turmoil of COVID and leadership turnover. Downstreet also retained its outstanding rating with Neighborworks. Dan also recognized certain staff who have taken on new and expanded roles over the last year.

He also thanked many of the partner organizations we have worked with who contribute to our success in many ways.

New business: Rick DeAngelis from GSH thanked the team for all the work they are doing with him. Several people on zoom provided "shoot outs" to staff and the organization.

It was noted Victor is not just a dog, he is a rescuer of hearts and an asset to the team.
